NLG Executive Appoints Interim Board of Nisga'a Valley Health Authority

November 30, 2017 – Gitlaxt'aamiks, B.C. - Nisga'a Lisims Government is pleased to announce the recent appointment of four highly qualified individuals to serve on the interim board of directors for the Nisga'a Valley Health Authority. The appointees are:

Angeline S.B. Nyce – a Nisga'a citizen and practicing lawyer in British Columbia with significant experience in corporate governance roles;

Robert J. Smith – a health administration expert with an extensive background in public governance roles and knowledge of the Nisga'a health system;

Amy Nyce – an active health care professional in northern British Columbia and a Nisga'a citizen; and Geoffrey Crampton – who brings his decades of experience in executive leadership positions in both the private and public sectors, and specifically in the human resources field of the health industry, to the role.

President Eva Clayton stated that, "Nisga'a Lisims Government set out to use its new appointing power to create a board with the right mix of education, experience and knowledge of the Nisga'a Nation's culture and traditions. We are very pleased with the directors that have been appointed, and believe they will work together to provide effective guidance to the Nisga'a Valley Health Authority, and to continue to improve the delivery of Nisga'a health services and the health of Nisga'a citizens across Canada."

The Nisga'a Valley Health Authority is a society incorporated under the Societies Act and is designated under Nisga'a law as the health services provider of the Nisga'a Nation.

Nisga'a Lisims Government made its appointments in accordance with the recent amendments to the bylaws of the Nisga'a Valley Health Authority that were voted on and unanimously approved by the members of the society at a members meeting held in the Nisga'a Village of Laxgalts'ap on June 29, 2017. These amended bylaws were reviewed and approved by the Ministry of Health (British Columbia) and empower Nisga'a Lisims Government to appoint qualified individuals to serve as directors of the Nisga'a Valley Health Authority.

BACKGROUND

In July 2015, the elected representatives of Wilp Si'ayuukhl Nisga'a requested that the Nisga'a Lisims Government Executive review the manner in which Nisga'a health services were delivered.

The Nisga'a Lisims Government Executive undertook an internal health system review and retained an objective, external consulting firm to perform the review and to prepare a report with recommendations to Nisga'a Lisims Government.

In conjunction with this review, Nisga'a Lisims Government oversaw a comprehensive health population survey in November and December of 2016. As a result of this health survey, the Nisga'a Valley Health Authority has a population health status profile which will allow them to target health services and track health outcomes for the Nisga'a Nation in the years to come.

In early-2017, the Nisga'a Lisims Government Executive received and considered the final report and recommendations flowing from its health systems review. Specific recommendations related to updating the membership and board structure of the Nisga'a Valley Health Authority through amendments to the society's bylaws.

The first update was to make the Nisga'a Nation as represented by the Nisga'a Lisims Government Executive the sole member to allow for a closer relationship between Nisga'a Lisims Government and the society.

The second update was to empower the Nisga'a Lisims Government Executive to appoint all directors to the board of the Nisga'a Valley Health Authority, in order to provide for the appropriate mix of education and experience Representatives of Nisga'a Lisims Government met with the board of the Nisga'a Valley Health Authority in March 2017.

The board of the Nisga'a Valley Health Authority was supportive of the initiative and draft amended bylaws were prepared. The board of the Nisga'a Valley Health Authority called a meeting of the members of the society to be held on June 29, 2017, to consider the proposed amended bylaws.

The members of the Nisga'a Valley Health Authority considered and unanimously adopted the proposed amended bylaws of the society at the June 29th meeting. On October 20, 2017, the Supreme Court of British Columbia confirmed the validity of this unanimous vote by the society's members, and shortly thereafter the Minister of Health (British Columbia) provided final approval to the proposed amended bylaws under the Hospital Act. The bylaws were filed and became effective on November 6, 2017.

On November 23, 2017, the Nisga'a Lisims Government Executive met to consider candidates for appointment to the board of the Nisga'a Valley Health Authority.



NOTICE IN ACCORDANCE OF NISGA'A LAW

NISGA'A FISHERIES AND WILDLIFE ACT

Please be Advised: The Sales of Fish and Aquatic Plants Harvested in Nisga'a Fisheries is a NISGA'A OFFENCE. The cash sale of fish is not considered to be trade or barter. Shell fish & Crustaceans Example: Cockles, clams, crabs

NISGA'A FISHERIES AND WILDLIFE ACT Definitions

1. in this Act.

"Aquatic plants" means all marine and freshwater plants, including kelp, marine flowering plants, benthic and detached algae, brown algae, red algae, green algae, and phytoplankton;

"Fish" means

- (a) Fish, including anadromous fish,
- (b) Shellfish, crustaceans, and marine animals,
- (c) The parts of fish, shellfish, crustaceans, and marine animals, and
- (d) The eggs, sperm, spawn, larvae, spat, juvenile stages and adult stages of fish, shellfish, crustaceans and marine animals

Trade or barter of fish harvests

- **11.** (1) Every Nisga'a citizen may trade or barter with other Nisga'a citizens or with other aboriginal people any fish or aquatic plants harvested under Nisga'a fisheries.
- (2) A person who, for the purpose of trade or barter, transports outside Nisga'a Lands fish or aquatic plants harvested under Nisga'a fisheries, must ensure that those fish or aquatic plants are identified, in accordance with the regulations, as being for trade or barter.

In October, 2017, School District #92-Nisga'a submitted an application to perform at the opening ceremony of the 2018 Annual General Meeting of the BC School Trustees Association (BCSTA) in Vancouver, BC. Out of 10 applications we were the selected group!


Students from grades 5 – 7 have been selected from the four elementary schools: Nisga'a Elementary, Gitwinksihlkw Elementary, Alvin A. McKay Elementary and Nathan Barton Elementary to represent the district and Nisga'a Nation in singing, dancing, and drumming while performing traditional Nisga'a songs and dances.

Students will be engaged in practices in each of the four communities over the next few months as they prepare to honour their culture, tradition and heritage as they will represent their schools, their communities, their families and the Nisga'a Nation. Students will be supported in their learning by local community members, family members, local leaders and elders from the Nisga'a Nation.

The BCSTA has provided \$4000 to assist with travel and the students will join together to raise the additional funds required to travel to and from the Nass Valley and Vancouver.

Nisga'a Highway sign installed at Kalum Lake Lookout



On October 27, 2017 the Rosswood Community Association installed the first of two commemorative signs at the Kalum Lake look out rest stop on Nisga'a Highway 113.

The sign reads:

'The Nisga'a Highway

This ancient transportation corridor between two major river systems, the Skeena and Nass, was originally used by Indigenous Peoples and later by trappers, miners, loggers, homesteaders and telegraph linemen. A public road finally connected the Kitsumkalum and the Nisaa'a territories in 1979.

JOB SUMMARY:

The Family Group Conference Coordinator has broad responsibilities to work with diverse community partners with respect to the delivery of family group conferencing within the various communities in the region. The position organizes family group conferences, ensures the family and other participants understand the purpose and process of the conference, and works with the family and the referring social worker to determine the terms and conditions of the conference. The Coordinator works closely with families and Aboriginal agency or Ministry of Children and Family Development (MCFD) staff to determine who is to attend a conference (involving community members as appropriate), conducts the conference and documents the outcome of the plan proposed by the family.

DUTIES:

- Plans and develops a process to carry out family group conferences (FGC), according to the procedures identified in MCFD's Family Group Conference
 Reference Guide. Uses approved data entry tools to record and track FGC outcomes. Provides regular progress reports on the usage and effectiveness
 of FGCs.
- Develops and delivers training and educational materials that provide an orientation for MCFD and delegated Aboriginal agency staff regarding the FCG
 process. Promotes awareness and encourages use of the FGC by communities/agencies serving families that have NCFS and MCFD involvement.
- Prepares for FGCs by assisting families to identify family members, extended family and other significant people who may participate in the conference, and by contacting the identified people to invite and prepare them for the conference. Works with families to identify the supports that they have and the supports that they will need to develop a workable plan to ensure the child's safety and well-being. Connects with community resources that can assist in FGCs though the provision of language or cultural interpretation, and ensures that the individuals selected are acceptable to the family. Identifies service providers in conjunction with both the child protection worker and the family.
- · Arranges logistics for setting up the conference including venue, transportation, refreshments and childcare.
- Facilitates FGCs where the family members meet with the service providers involved with the case (including the child protection social worker) in a manner that is respectful of and empowering to families and that allows the family to participate fully in decision-making.
- Plans, prepares for and implements a review process with the agreement of the participants.
- Prepares and tracks budgets assigned to the Family Group Conferencing initiative to ensure the most effective use of resources and prepares
 documents for presentation to court as required.

EDUCATION / KNOWLEDGE / SKILLS / ABILITIES:

- · Post-secondary education in a related field is highly preferred; extensive directly related experience may be considered
- Excellent interpersonal, written and verbal communication skills including an ability to communicate complex information to a wide variety of audiences;
- Demonstrated professionalism, judgement, diplomacy, tact, and sound decision making ability;
- Ability to prioritize, organize and manage a workload often including multiple, competing demands;
- Knowledge of the Nisga'a language and culture is a definite asset;
- Must have a valid BC Driver's license and be able to travel as required.

- 2. Three recent work related references;
- The successful candidate will be subject to a criminal records check;

Currently, Nisga'a Lisims Government has an exciting new position for a Communications Coordinator to join the group in Gitlaxt'aamiks (also known as New Aiyansh) in beautiful British Columbia.

Under the direction of the Director of Communications and Inter-governmental Relations, you will be responsible for providing communication services to departments of Nisga'a Lisims Government (NLG). The Communications Coordinator works in the administrative offices of NLG, and supports implementation of the NLG communication strategy, and will provide support in writing, editing and producing consistent and quality communications materials for NLG, particularly in respect of desktop publishing, website, social media, and photography.

More specifically, on a regular basis you will have the following responsibilities:

- Supporting NLG's communications strategy through communications activities including public and media relations management on behalf of NLG.
- Liaising with staff from various NLG departments and the general public to respond to requests for information, as well as to collaborate on joint initiatives and events.
- Handling the media and coordinating responses for identified NLG spokesperson.

- 3. the Director of Lands and Resources, on behalf of the Executive, be authorized to deliver to Jesse Dyer, for execution and return, a lease substantially in the form attached to this motion as Appendix "A": and
- 4. upon:
 - a. the execution by Jesse Dyer and return to the Director of the lease delivered under paragraph (1) along fees requested under the terms of the lease,
 - b. the provision of the regulatory permits and authorizations required by Jesse Dyer to commence clearing and develop the Land, and
 - c. the consultation obligations with the Province of British Columbia under paragraph 45 of chapter 7 of the Nisga'a Final Agreement having been met, the Director be authorized to date and execute the lease on hehalf of the Executive.
