



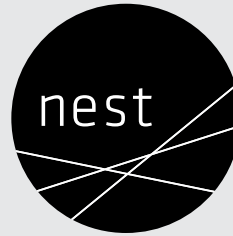

Red Mountain Underground Gold Project Open House Complete, and Open for Comments Until Nov. 4

Environmental Assessment of the Proposed Red Mountain Underground Gold Project

Open House *and* Invitation to Comment

IDM Mining Ltd. (the Proponent) is proposing to construct and operate an underground gold and silver mine in the Regional District of Kitimat-Stikine. The Red Mountain Underground Gold Project (the proposed Project) is located approximately 18 km northeast of Stewart, in the Bitter Creek Valley. The proposed Project would include a mineral processing facility with a capacity of up to 1,000 tonnes per day.

The proposed Project is subject to review under British Columbia's *Environmental Assessment Act* and the *Canadian Environmental Assessment Act, 2012*.

The Proponent must obtain an environmental assessment certificate before any work can be undertaken on the proposed Project. Prior to the Proponent's submission of an application for a certificate (Application), the Environmental Assessment Office of British Columbia (EAO) must first approve the Application Information Requirements.

The Application Information Requirements will specify the studies to be conducted and the detailed information to be provided by the Proponent in its Application. EAO has now received the draft Application Information Requirements from the Proponent and invites comments on this draft.

In order to provide information about the Application Information Requirements, EAO invites the public to attend an Open House. The Open House will be held as follows:

All comments received during this comment period in relation to the Application Information Requirements will be considered.

The intention of seeking public comments is to ensure that all potential effects (environmental, economic, social, heritage and health) that might result from the proposed Project are identified for consideration as part of the assessment process. At this stage of the process, the primary intent is to receive feedback about the studies or information required for a comprehensive environmental assessment.

After taking public comments into account, EAO will finalize the Application Information Requirements and issue them to the Proponent.

Transport Clients to Health Centres for Medical Emergencies

"A medical emergency is a situation that if left for even a short period of time could cause death or serious problems to a person's health." A client with a severe, life or death situation ***must be safely transported to the clinic for the nurse to provide the best care possible – to provide the client with the treatment and tests needed in a timely manner.*** If assistance is required to help transport a client to the health centre, there are First Responders available to assist.

Home visits are not recommended as time and proper care can be critical in a medical emergency. The medical equipment and medication needed to treat someone in medical distress are at the clinic, for example:

- If a client is having chest pain, nausea, dizziness or has very high blood pressure, an ECG needs to be completed. The ECG machine cannot be brought to the home.
- If a client is having a heart attack, the lifesaving medication and equipment are in the clinic.
- If a person is too ill to walk independently or is so ill, he or she cannot get out of bed, this is an emergency that needs to be assessed in the clinic.
- Nurses do provide home visits for palliative and home care clients. However, if a home care client's arthritis is flaring up, for example, it could be an illness that needs to be assessed at the clinic, and with proper assessment, the infection can be treated in a timely manner.

Please ensure that clients are brought to the health centres in a medical emergency to ensure the best possible medical care is provided, and provided in a timely manner.

Summary of Position:

The Emergency Services Coordinator (ESC) will be responsible for the organization and direction of all Emergency Service Departments, to ensure that the quality of emergency response services to prevent or minimize loss of life, injuries and property damage due to an emergency incident. The ESC will take a leading role in coordinating emergency planning, preparedness and emergency volunteers in the Fire Department, Marine and Ground (Search and Rescue), Emergency Medical Responders, Village Security and Enforcement to work collaboratively under one organizational umbrella. The ESC will be responsible for the maintenance of all emergency operations and services within Gingolx BC. The ESC will coordinate emergency training and cross training for a wide range of emergency and crisis response. The ESC will take the sole command on the site of an emergency event.

Responsibilities:

- To review, develop and implement all emergency department policies and procedures in accordance with Gingolx Village Laws, Nisga'a Lisims Government Laws, Provincial Laws and Federal Laws and Legislation.
- To direct all activities at an emergency scene, to ensure all emergency volunteers and emergency teams are responding in a safe and appropriate manner.
- To ensure all emergency personnel are operating in regulation with PPE and safety measures.
- To investigate and document all emergency scenes for reporting to appropriate government agencies.
- To recruit dependable reliable personnel for emergency crisis training, activities for emergency services.
- To ensure that the trained recruits are ready and available in the event of a fire, emergency or crisis response.
- To develop, coordinate, facilitate and maintain emergency crisis management
- To provide technical knowledge on emergency preparedness and related issues, plans and training programs, emergency operation drills, department level emergency and mitigation plans.
- To ensure a high level of morale among all emergency volunteers and tactical teams.
- To facilitate training and evaluate performance of all emergency personnel.
- To work in collaboration with Gingolx Village Government, the RCMP, the Health Clinic, Medical Staff and Emergency Services
- Administrative tasks, maintain records on emergency incidents of fire, injuries, loss of life and property. Prepare reports on all areas of emergency services, monitor emergency budgets.
- Implement fire prevention education programs and fire permits.

TERRACE – Skills training and new employment opportunities will be high on the agenda as the Nisga'a Employment Skills Training (NEST) program hosts 14 British Columbia Aboriginal Training Employment Alliance Members (BCATEAM) from across the province in Terrace and Gitlaxtaamiks from September 13-15.

"The Nisga'a Lisims Government and NEST are honoured to have representatives from aboriginal skills training and employment programs throughout BC come to our home to participate in this important meeting," says Mitchell Stevens, President of the Nisga'a Nation.

Adds Gary Patsey, Manager of the Nisga'a Employment, Skills & Training program:

"The BCATEAM and its members are key and significant stakeholders for union, industry and government to coordinate employment, skills and training initiatives for all Indigenous people across BC. The BCATEAM cooperates amongst each other and as a group collaborates with other leadership groups in BC and on a national level."

AND CONSIDERING THAT the Executive wishes to bring the *Enforcement Act* into force;

MOVED THAT:

1. under the *Enforcement Act*, the Executive enact the *Nisga'a Real Property Tax Enforcement Act In Force Regulation* attached to this motion as Appendix "A" (the "In Force Regulation");
2. the In Force Regulation come into force on the date it is signed by the President of Nisga'a Lisims Government (the "President"); and
3. the President be authorized:
 - a. to sign this Resolution; and
 - b. to sign the In Force Regulation to evidence its enactment.

Resolution 2016 / 88

CONSIDERING THAT under the *Nisga'a Real Property Tax Enforcement Act* (the "*Enforcement Act*"), the Nisga'a Lisims Government Executive (the "Executive") is authorized to make regulations for purposes of the *Enforcement Act*;

AND CONSIDERING THAT the Executive considers it advisable to exercise its regulation-making authority under the *Enforcement Act*;

 - a. to sign this Resolution; and
 - b. to sign the Enforcement Regulation to evidence its enactment

Resolution 2016 / 89

CONSIDERING THAT under section 2(1) of the *Nisga'a Real Property Tax Enforcement Act* (the "*Enforcement Act*"), the Nisga'a Lisims Government Executive (the "Executive") is mandated to appoint a person as the collector of taxes for the Nisga'a Nation under the *Enforcement Act*;

MOVED THAT, under section 2(1) of the *Enforcement Act*, the Executive appoint the Chief Financial Officer of Nisga'a Lisims Government as the collector of taxes for the Nisga'a Nation under the *Enforcement Act*.

Resolution 2016 / 90

CONSIDERING THAT under section 9 of the *Nisga'a Real Property Tax Act* (the "*Act*"), the Nisga'a Lisims Government Executive (the "Executive") proposes to enact a permissive exemptions regulation substantially in the form attached
