

## Public Notice of Proposed 2018 Property Tax Permissive Exemptions

Notice is hereby given pursuant to section 10 of the *Nisga'a Real Property Tax Act* that the Nisga'a Lisims Government Executive proposes to enact the *Nisga'a Permissive Exemptions Regulation, 2018*, under which the following properties will be exempt from 2018 Nisga'a property tax. Unless otherwise specified under the heading "Civic Address", all land and improvements at each listed address will be exempt.

Section 9(4) of the *Nisga'a Real Property Tax Act* does not require the publication of notice of exemptions from Nisga'a property taxes that may be provided under section 9(2)(a) [land or improvements related to timber harvesting], 9(2)(b) [land or improvements related to social housing], 9(2)(g) [land or halls related to buildings set apart for public worship] or 9(2)(i) [land related to hospitals or private schools] of the Act.

It is anticipated that the Nisga'a Lisims Government Executive will consider enactment of the proposed *Nisga'a Permissive Exemptions Regulation, 2018* at its regularly scheduled meeting in October of 2017.
