# 60 Nisga'a Workers On Transmission Line

### Hello & Greetings to All,

As you may know and have seen around the Nass Valley, the Northwest Transmission Line Project has been in full swing since the second week in July 2012. We have been picking up the pace as the months pass.

Nass Area Enterprises Ltd Partnership currently has 37 employees working within our company. The positions include the finance department, hiring coordinator, right of way coordinator, project manager, construction safety officers, first aid level 3 attendants, environmental monitors, fallers, brushers & labourers.

There are six sub-contractors who are also working on the Northwest Transmission Line Project along side of Nass Area Enterprises Ltd Partnership – Timber Baron Contracting, Simms/Sharp Group Contracting, Laxgalts'ap Forest Company, Laxgalts'ap Village Government, Gitlaxt'aamiks Village Government & Nisga'a Commercial Group.

Each sub-contractor has hired Nisga'a workers as well from our NAE resume database of employable Nisga'a. It brings up the current total to 60 Nisga'a workers in all. We have hired from all four communities in the Nass Valley as well as the surrounding Nisga'a urban communities.

Nass Area Enterprises Ltd Partnership's central office is located in Nass Camp, BC and we also have another smaller NAE office in Terrace BC. We accept resumes from all different areas of work, and we encourage everyone to email, fax or hand deliver their resumes to Nass Area Enterprises Ltd Partnership [email: paula@naeltd.ca, fax: (250) 633 2459; or drop off at Nass Camp].

We are coming close to the Christmas holidays & NAE will be shut down for the holidays as of December 21, 2012 until the New Year 2013. Looking ahead into the New Year 2013, we will be seeing a lot more work being done on the Northwest Transmission Line Project. NAE will be submitting a report monthly following this report in the new year of 2013.
