## Nisga'a Nation positioned for LNG opportunity

**VICTORIA** / The Province and the Nisga'a Lisims Government today are celebrating the passage of two key pieces of legislation and two economic benefit agreements that support the Nisga'a Nation's effort to become a major participant in B.C.'s liquefied natural gas export economy.

The B.C. legislature passed the Nisga'a Final Agreement Amendment Act today which establishes the Nisga'a Lisims Government as the property taxation authority over Nisga'a Lands, the 2,000 square kilometres of lands the Nisga'a Nation owns and has legislative jurisdiction over under the Nisga'a Treaty.

On July 31, 2014 the Nisga'a Nation signed a tax agreement with British Columbia to implement the tax provisions of the Nisga'a Final Agreement that gave the Nisga'a Nation the ability levy and collect property taxes on our lands. The legislation passed today will ensure that the Nisga'a Nation will benefit from the property taxes paid by LNG pipelines and other industrial developments that will take place on Nisga'a Lands.

On November 6, 2014 the Nisga'a Nation signed a Benefits Agreement with Prince Rupert Gas Transmission Ltd. which assures project certainty to PRGT and provides the Nisga'a Nation with numerous financial and other benefits including an option to transport natural as through the pipeline.

Last week on November 20, 2014 the Nisga'a Nation signed a Benefits Agreement with the Province of BC in support of the PRGT project, which provides PRGT with certainty for developments on Nisga'a lands.

Next week, we will return home to our own legislature to enact our taxation legislation to complete the process to establish the Nisga'a Nation property taxation system.

Since the effective date of the Treaty in May 2000, we have been committed to achieving sustainable prosperity and self-reliance for our people through establishing this tax regime which was provided for in the Nisga'a Treaty.

We believe that we can not only benefit from this industry for our people, but also make contributions to the establishment of this industry in BC.

The opportunities available to the Nisga'a Nation are the types of opportunities for which our ancestors fought for over a century, to assure our collective future prosperity into the next century. These agreements are important for our people and are another step towards achieving sustainable prosperity for the Nisga'a Nation.

All of this has been achieved without surrendering any of our interests in Nisga'a Lands. We continue to own the 2,000 sq. km of Nisga'a Lands that we owned before we entered into these Agreements.

Moreover, exercising our rights under the Environmental Chapter of the Nisga'a Treaty, we have protected our lands, our waters, our fisheries, and our wildlife for our people to ensure that we can also continue our way of life living on the land as we have done since time immemorial.

The benefits we have secured under these Agreements will form part of the transformation and improvement to our quality of life that has been long hoped for by the Nisga'a Nation.

Our elders understood that once our rights had been protected and perfected by our Treaty, it would ensure that the Nisga'a Nation would become an active participant in any significant economic activities in the Nass Area. We can affirmatively state that our Treaty has made this progress possible today.

Finally, we take this moment to serve notice to the LNG sector that as a result of our agreement with PRGT, we hold the option to an unparalleled opportunity for an LNG investor to join the Nisga'a Nation in bringing LNG to market. The Nisga'a Nation holds an option to transport natural gas in the pipeline to an LNG liquefaction facility to be located on Nisga'a Lands. We invite interested LNG investors to contact us about our 4 strategically located sites which are ideally suited for LNG development and shipment overseas.

In closing, we would like to acknowledge and thank the Province of British Columbia for enacting this legislation and joining us in partnership in providing certainty for investment in the Province of British Columbia.

The legislation enables the Nisga'a Nation to levy and collect property tax from persons other than Nisga'a citizens, including companies that operate industrial installations, such as LNG pipelines and infrastructure. It gives effect to the Real Property Tax Co-ordination Agreement between the Nisga'a Nation and the Province, the provisions of which are available only to modern treaty First Nations.

The B.C. legislature also passed the *Protected Areas of British Columbia Amendment Act*. The legislation is a first step in a process to remove 63.5 hectares from Nisga'a Memorial Lava Bed Park, a provincial park jointly managed by the Province and the Nisga'a Nation under the Nisga'a Treaty. The land to be removed from the park is to facilitate a right-of-way corridor for Prince Rupert Gas Transmission's (PRGT) proposed 900-kilometre pipeline project.

Last month, the Nisga'a Nation concluded a Benefits Agreement with Prince Rupert Gas Transmission Ltd. which provides for substantial financial and other benefits to the Nisga'a Nation, including an option to transport a fixed amount of natural gas through the PRGT pipeline. The Nisga'a Nation is actively seeking investors to utilize this option to locate an LNG liquefaction facility on Nisga'a Lands.

Last week, the Nisga'a Nation and the Province entered into a Benefits Agreement for significant financial benefits in relation to the proposed PRGT pipeline.

Both agreements provide substantial benefits and business opportunities to the Nisga'a Nation and certainty for the proponent within Nisga'a Lands and the Nass Valley.

These legislative amendments and agreements demonstrate the many types of benefits related to LNG available to First Nations. Benefit sharing with First Nations is the path to partnership on economic development, and complements industry impact benefit agreements that provide jobs and economic development.

The Nisga'a Treaty is the first modern-day treaty in British Columbia. It provides constitutional certainty in respect of the Nisga'a Nation's right of self-government and economic, social and cultural benefits envisioned by the Nisga'a Nation's chiefs and elders and has been an inspiration to Indigenous people across Canada and internationally.

#### Quick Facts:

- Nisga'a Nation will receive about \$6 million from a
  Prince Rupert Gas Transmission (PRGT) pipeline benefit
  agreement from the Province and a yet-to-be-determined share of \$10 million per year in annual benefits.
- Nisga'a Nation also signed a benefit agreement with PRGT on Nov. 6, 2014.
- The Nisga'a Final Agreement Amendment Act gives effect to the Real Property Tax Co-ordination Agreement

(RPTCA) between the Province and the Nisga'a Nation.

- Under the RPTCA, the Nisga'a will be able to collect property taxes from residential and industrial properties on Nisga'a Lands, including LNG pipelines and infrastructure.
- TransCanada's PRGT project is proposed to run 900 km from northeast B.C. to the proposed Pacific NorthWest LNG export facility at Lelu Island near Prince Rupert.
- The pipeline route would run approximately 97 kilometres through Nisga'a Lands and the Nisga'a Memorial Lava Bed Park.
- The Province is collaborating with First Nations, industry and federal agencies on First Nations-driven LNG Environmental Stewardship Initiative.
- This fall, the B.C. government announced rates for LNG proponents connecting to BC Hydro's electrical grid, introduced the LNG Income Tax Act, and legislation to ensure B.C. has the cleanest LNG facilities in the world.

## Majagaleehl Nisga'a marches in Grey Cup Parade

Concert bands have been a staple in modern Nisga'a society since the late 1800s. The New Aiyansh Harmonic Silver Band, Gitwinksihlkw Brass Band, Greenville Concert Band and Kincolith Concert Band have seen generations of men and women carry on the traditions and musical talents that are still alive and well today.

On Saturday November 29, it was a journey of historic proportions for Majagaleehl K'alii-Aksim Lisims as they lit up the streets of downtown Vancouver rendering their harmonic and upbeat musical selections as they proudly marched in the 102nd Grey Cup Parade.

Historic and monumental in not only the sense that it is the farthest and largest metropolitan city the united Nass Valley band has ever travelled – but also because in the short time frame in which they had to prepare for their journey south, they brought the four Nass Valley communities together to work toward their common goal as the Nisga'a United Band and in the spirit of Sayt-K'ilim-Goot.

In recent years each community band had experienced the loss of many of the senior, more experienced members and a decline in newer, younger membership. However the presence of the bands was still notable at community functions such as weddings, festivals, memorials, funerals and other community events with a core group from each community keeping the tradition strong and alive. When the united band received their invitation to participate in the 102nd Grey Cup parade it was then that the core band members embarked on a recruitment campaign to invite new members to join in on the historic journey, forcing some out of retirement and others to dust off the instruments from high school.

With well over 100 members, the Nisga'a United Band began an intensive two month fundraising campaign with an overwhelming show of community, Nisga'a Government and corporate support — making their ultimate goal achievable and a remarkable success.

The band scheduled their practices twice weekly on a rotational basis throughout each of the four Nisga'a Villages, ending each week with a third marching practice marvelling



the streets of each Nisga'a village with their joyous upbeat medley. Community onlookers were drawn out of their houses to observe practices and to join in the joyous marches — many opening their wallets to offer what financial contributions they could in support of the band's fundraising efforts.

In the final days leading up to the journey to the Grey Cup, the band hosted a formal gala concert and fundraiser in Laxgalts'ap that attracted hundreds from all over the Northwest. The following day they ventured to Terrace to perform for a roaring, celebratory crowd at the REM Lee Theatre. Upon arrival in Vancouver, the united band was then welcomed in a formal banquet by the Nisga'a Community of Ts'amiks at the Vancouver Aboriginal Friendship Centre where they delivered another stellar performance to a joyous crowd.

And then the day arrived. Show time for Majagaleehl Nisga'a was now upon them on that cold November morning, where they would perform for thousands of parade onlookers in the 102nd Grey Cup parade. Did they deliver!

In the crowds of thousands that lined the downtown Vancouver streets were many beaming, proud Nisga'a supporters — many elderly who were nostalgic and brought back to a time when the flower of Nisga'a communities were a force to be reckoned with.

The Nisga'a United Band re-awakening did much for all of us and we thank them for bringing about the "Happy Days" through the fine art of music once again.

## NESS commemorates Unity Day 2014



**NISGA'A UNITY DAY /** celebrated annually on November 1st – is a significant day to commemorate the opening of School District #92 (Nisga'a) on November 1, 1977.

37 years later, the powerful symbol of that glorious day stands toweringly overlooking the Nass Valley as a reminder to us today of the tireless efforts of our leaders to bring K-12 education home to the Nass Valley.

The Unity Pole – carved by W'ahlin Sim'oogit W'ii Gadim Xsgaak, the late Eli Gosnell – was a feat in itself in that it was the first totem pole carved and raised in the Nass Valley in over a century.

The first generation of students that walked through the doors of a shiny new Nisga'a Elementary Secondary School (NESS) 37 years ago would be parents and grandparents now – some with grandchildren that are present-day NESS pupils.

On Monday November 3, 2014 NESS students and faculty hosted a belated Unity Day celebration at NESS. The Council of Elders were invited to participate with the youth in workshop-style discussion groups. The topic: 'What does respect and compassion mean to you?'

Students were divided in to groups by tribe. In the first session members of the Council of Elders delivered talks about unity and respect – providing students invaluable lessons on the history of the creation of the school district, and offering yuuhlimk'askw (counselling) on the importance of kwhlixoosa'anskw (respect).

As one can remember being an adolescent, shyness may overcome you. So while the discussions with elders were not the most engaging, it was apparent that the students showed an earnest willingness to respectfully listen.

An assembly followed in the gymnasium to conclude the days' festivities where 6 young ladies exemplified great leadership and courage as they stood in front of their peers to deliver their carefully crafted essays on the meaning and importance of respect.

Among them was high school senior Darrian Mills, a Ksim Laxgibuu from Wilps N'agwa'un of Laxgalts'ap. Darrian was acknowledged by Gitlaxt'aamiks Chief Councillor Gerald Robinson for her work in spearheading the writing of an apology letter to elders and community leaders. After witnessing disrespectful behaviour at a back to school march at the beginning of the school year, Darrian was compelled to write the letter and then collected some go signatures from her peers. Chief Councillor Robinson presented Darrian and her peers with a carved feather and an eagle feather for their tremendous show of respect.

Darrian later concluded her essay delivery so eloquently, "My fellow students of NESS, we're not always going to have our elders. One day it is going to be us. We are going to be future leaders of the Nisga'a, so that's why it is important for us to learn right now because we're sponges, we're so young. It's important for us to learn respect now."

## Nisga'a Moose Hunting Season

**NISGA'A MOOSE HUNTING SEASON** is open for the successfully drawn permit holders from December 1, 2014 to January 15, 2015.

Each participant will require the following items:

- 2014/15 Nisga'a Moose permit
- · a valid Nisga'a Hunting License
- a valid Nisga'a Citizenship Card
- a valid PAL

Pursuant to the Nisga'a Annual Wildlife Management Plan, the moose harvest allocation is 25 Bull only.

Any citizen who was successful in obtaining a permit, must be actively hunting for the permit to be valid as this permit is non-transferable.

All other BC/Federal Regulations need to be adhered to including:

- · Road closures
- No shooting areas (ie. within village limits)
- · No shooting from vehicles
- No hunting at night

## Nass River Bridge Replacement and North Detour Route Status Update



## North Detour Route: notification of unmaintained road

The North Detour Route is located 35 km north of the Nass-Cranberry Junction on Highway 37. It provides access to the north side of the Nass River Bridge (Kinskuch FSR) and the Avanti Kitsault Mine Site via the Arbor FSR (0 to 2.5 km), Niska FSR (0 to 41 km), and Kinskuch FSR (15.8 to 40.3 km). This route will not be maintained and could be impassible during the winter months.

During the Nass River Bridge Replacement at Km 14.7 of the Kinskuch Forest Service Road access to the north side of the bridge and the Avanti Kitsault Mine Site will be limited. No thru vehicle or pedestrian traffic will be able to cross the bridge from November 19, 2014 through February 28, 2015.



# Summary of Resolutions from NLG Executive Meeting November 25 and 26, 2014

The following is a summary, and for certain resolutions an excerpt, of NLG resolutions from the most recent meeting of the NLG Executive.

## Resolution / Adopted Nov 25, 2014 Banking Services RFP

#### MOVED THAT the Executive

- approve the distribution of the Banking Services RFP to eligible banking service providers; and
- 2. direct that the Finance Committee review the responses to the Banking Services RFP and formulate a recommendation for Executive's consideration.

#### Resolution / Adopted Nov 26, 2014 Nisga'a Real Property Tax Act

MOVED THAT the Nisga'a Lisims Government Executive recommend to Wilp Si'ayuukhl Nisga'a the enactment of legislation substantially in the form of the Nisga'a Real Property Tax Act attached to this motion as Appendix "A".

- (1) the Nisga'a Nation, as represented by the Nisga'a Lisims Government Executive, enter into the Services and Requisitions Agreement with the Regional District; and
- (2) the Secretary-Treasurer, on behalf of the Nisga'a Nation as represented by the Executive, be authorized to execute the Services and Requisitions Agreement.

#### Resolution / Adopted Nov 26, 2014 Licence of Occupation — Mr. Doolan

MOVED THAT the Executive authorize

- 1. the Director of Lands and Resources to offer the Licence of Occupation to Mr. Doolan; and
- 2. the CEO to execute the Licence of Occupation on behalf of the Nisga'a Nation.

#### Resolution / Adopted Nov 26, 2014 Licence of Occupation — Mr. Robinson

MOVED THAT the Executive authorize

- 1. the Director of Lands and Resources to offer the Licence of Occupation to Mr. Robinson; and
- 2. the CEO to execute the Licence of Occupation on behalf of the Nisga'a Nation.

#### Resolution / Adopted Nov 26, 2014 26 new lots

#### MOVED THAT:

- (1) the Executive consent to the Approving Officer's approval of the Plan on the condition that the Village first enter into a covenant with the Nisga'a Nation under section 142 of the Act in respect of each of the 26 new lots proposed for the Lands, in substantially the same form as the covenant attached to this motion as Schedule "B", with such modifications, if any, as may be determined to be appropriate by the approving officer and legal counsel (the "Covenant");
- (2) the Director of Lands and Resources be authorized to execute the Covenant on behalf of the Nisga'a Nation in respect of the 26 new lots, and be authorized to apply for the registration of the Covenant as a charge against each of those lots under the Act.

## Resolution / Adopted Nov 26, 2014 Three new lots

#### MOVED THAT:

- (2) the Director of Lands and Resources be authorized to execute the Covenant on behalf of the Nisga'a Nation in respect of the three new lots, and be authorized to apply for the registration of the Covenant as a charge against each of those lots under the Act.

#### Resolution / Adopted Nov 26, 2014 Approving Officer Appointment — Mr. Eric Nyce

MOVED THAT Mr. Eric Nyce be appointed as the Approving Officer for land under section 63 of the Nisga'a Land Title Act effective immediately.

#### Resolution / Adopted Nov 26, 2014 RPTCA Transitional Agreement

#### MOVED THAT:

- (1) the Nisga'a Nation, as represented by the Nisga'a Lisims Government Executive, enter into the RPTCA Transitional Agreement with British Columbia; and
- (2) the Secretary-Treasurer, on behalf of the Nisga'a Nation as represented by the Executive, be authorized to execute the RPTCA Transitional Agreement.

#### Resolution / Adopted Nov 26, 2014 Revised Stipends Bulletin

MOVED THAT the Executive adopt the Revised Stipends Bulletin effective April 1, 2014.

In addition to the items referenced above, regular business carried out by the Executive of Nisga'a Lisims Government includes opening prayer, adoption of agenda, minutes and financial statements.
