ELECTOR REGISTRATION

Resident Electors

- 18 years of age or older on General Voting Day – October 17, 2026;
- A Canadian citizen;
- A resident of British Columbia for at least 6 months immediately before the day of registration;
- A resident of the applicable Electoral Area on the day of registration, and
- Not disqualified under the Local Government Act or any other enactment from voting in an election or assent voting and not otherwise disqualified by law;

Non-Resident Property Electors

- 18 years of age or older on General Voting Day – October 17, 2026
- A Canadian citizen;
- A resident of British Columbia for at least 6 months immediately before the day of registration;
- A registered owner of real property in the applicable Electoral Area for at least 30 days immediately before the day of registration;
- Not entitled to register as a resident elector; and
- Not disqualified under the Local Government Act or any other enactment from voting in an election or assent voting and not otherwise disqualified by law.

For non-resident property electors, the registered owners of the property must be individuals who are not holding the property in trust for a corporation or another trust. If more than one individual owns the property, only one may register as a non-resident property elector, with the written consent of the majority of the individual owners.

Identification required

Resident electors must produce two (2) pieces of identification, at least one with a signature. Picture identification is not necessary. The identification must prove identity and place of residence. Non-resident property electors must produce two (2) pieces of identification, at least one with a signature, proof of entitlement to register in relation to the property and, if applicable, written consent from the majority of the other property owners.

Types of Documents Accepted as Identification

Accepted classes of identification include: Driver's Licence; BC Services Card (photo or non-photo); ICBC Owner's Certificate of Insurance and Vehicle Licence; BC Care Card or BC Gold Care Card; Monthly Form EA181; Social Insurance Number Card; Citizenship Card; real property tax notice; credit or debit card; or utility bill. Election Officials may also accept other documents that provide satisfactory evidence, such as a valid, current passport.
